#### Eligibility

The tournament is open for player who have not crossed the standard FIDE rating of 1600 in the past 36 months prior to the start of the tournament are eligible to participate.

#### System of Play

The Tournament shall be played under the FIDE Laws of Chess for a total of 9 rounds on a Swiss - League basis.

### Time Control

Each player shall have 30 minutes with an increment of 30 seconds per move starting from move one.

### Fair Play

Players who finished first or second in any rating restricted tournament will not be eligible to play in any rating restricted tournament for one year from the date of such achievement.

### AICF Player Registration

AICF and TGCA Registration 2025-2026 for Indian Players:

All Indian participants shall be registered with AICF for the year 2025-26 before submitting entry for this tournament.

### Prize Money Notes

The prizes shall not be shared and a player would be eligible for one higher prize only.

Tax will be deducted as per the Indian Tax Act.

All payments to Indian players would be made by bank transfer.

Prize winners from foreign countries would be required to submit a copy of their passport & visa.

### Default Time (Walkover Time)

The default time will be 15 minutes.

### Tie-Break

Following tie break will be implemented:

- Buchholz Cut 1
- Buchholz
- SONNEBORN\_BERGER
- Direct Encounter
- Greater number of wins (Including forfeit points)
- Greater number of wins with black pieces.

## Protest

Protest, if any, against the decision of the Chief Arbiter, shall be made-in-writing with a protest fee of Rs. 5000/- (Rs. Five Thousand Only) within 30 minutes of the occurrence of the incident. The amount would be refunded if the appeal is upheld.

## Appeals Committee

Appeals committee will be formed in the technical meeting. The decision of the said committee shall be final and binding on all the participants.

## Interpretation of Rules

For further interpretations of the rule(s) and deciding any aspect not covered by the said tournament prospectus, the decision of the Tournament Director shall be final and binding on all the participants. The Tournament Director has every right to make any addition / deletion / amendment to these rules. However, such changes shall be displayed on the notice board.

Players are not allowed to carry bags, mobile phones, wrist watches and other electronic devices to the playing arena. Arrangements will be made for the players to deposit their bags mobile phone etc.
